

RULES OF THE GAME
6of49 GAME – TERMS & CONDITIONS

1. The Organizer of the 6of49 Game:

- 1.1. SET PLC (Secure Electronic Technology Plc.), licensed by the Federal Government of Nigeria in accordance with the Lottery Act of 2005 to conduct and promote lotteries nationally throughout Nigeria
- 1.2. Legal address: 107 Bamgbose Street, By Campos Square, Lagos Island, Lagos, Nigeria.

2. The name of the game:

- 2.1. «6of49 JACKPOT LOTTERY GAME: **Text Your Money-Maker!!!** »

3. Location:

- 3.1. Nigeria

4. Time frame of the game:

- 4.1. The game “6of49” will run throughout a one year period, after which it is renewable. Please check online at <http://www.setplc.com>, or call the Customer Care number(s) (**09086314669, 09086314670, 09086314671 and 09086314672**)

5. Acceptance of Terms of Use

- 5.1. All participants warrant that they have read these Terms and Conditions carefully and fully understand which are on public view at <http://www.setplc.com>.
 - 5.1.1. by sending your 6-number predictions per SMS play @ NGN 50.00 to the short code **22591** (the **Short Code**), the participants signal their complete acceptance and full understanding of these Terms and Conditions and agree:
 - 5.1.2. to receive SMS communication from the Organizer on their mobile phones relating to the “6of49 Game”;
 - 5.1.3. to receive SMS communication/advertising offers from the Organizer or from other companies that cooperate with the Organizer.
- 5.2. The Organizer reserves the right to cancel or amend the offer and these Terms and Conditions at any time. Any changes will be posted online at <http://www.setplc.com>
- 5.3. In the event of dispute regarding the Terms and Conditions, conduct, results, and all other matters relating to the Game, the decision of the Organizer shall be final and no correspondence or discussion shall be entered into.
- 5.4. This Agreement will remain in full force and effect while the Organizer provides the offer (not taking into account temporal suspensions of the offer for operational reasons, e.g. for repairs, planned maintenance or upgrades).

6. Participants of the game:

- 6.1. The following are eligible to participate:

- 6.1.1. Natural persons (other than people employed by the Organizer (Participating Telco and SET Plc staff), for the period of the Game and also their spouses), who are customers of the participating GSM Operator in Nigeria during the period of the Game.
- 6.1.2. Any Telco subscriber above the age of **18**
- 6.1.3. Legal entities during the period of the Game. Only an authorized signatory on behalf of the legal entity will be entitled to take receipt of the prize.
- 6.1.4. The Organizer reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any provision of the Terms and Conditions.
- 6.1.5. By participating in the Game, entrants hereby warrant that all information submitted is true, current and complete.

7. Availability and accessibility of information and Opt-out mechanism

- 7.1. All the information for the participants of the Game with regards to the Game shall be published on the website (<http://www.setplc.com>), as well as available by calling the Customer Care number(s): **(09086314669, 09086314670, 09086314671 and 09086314672)**
- 7.2. Information about the predictions (participations/chances) played by the participants during the Game will be sent to the participants in SMS messages automatically after receiving SMS message from the Organizer.
- 7.3. Each participant can drop out of the Game by simply ignoring any broadcast messages from the network. If after the participant chooses to send a new SMS message to the Short Code, he/she will be again considered as a participant in the Game.
- 7.4. If the Game is terminated, the Organizer of the Game will publish in the official resources of the Game (<http://www.setplc.com>) a message about the termination of the Game.
- 7.5. Interruption or early termination of the Game shall not release the Organizer from its obligation to give out already awarded tier winnings and execute other actions required, except for the cases when termination or interruption of the Game was called by actions or events which are not under the Organizer's control
- 7.6. The Organizer of the Game shall not release personal information about participants of the Game to any third persons unless required to do so by law or in order to comply with Nigerian government entities and in accordance with the paragraph 14 of the Terms and Conditions.
- 7.7. The Organizer reserves the right not to enter into written negotiations or otherwise contact with the participants of the Game other than in accordance with the Terms and Conditions or in accordance with the requirements of the current legislation of Nigeria.

8. Regulations of participation in the game:

6 of 49 is a pari-mutuel game, where 6 lucky numbers are picked from 1-49, spacing your numbers or you send QP6 to 22591 via mobile phone. Prizes are derived from the ticket sales, whereby a percentage sharing is distributed across all categories.

To participate in the Game the participant must:

- 8.1. Either chooses his/her 6 lucky numbers from 1-49 and send via SMS to 22591 OR a player can choose to send "QP6" to 22591 and the system will automatically generate 6 numbers for him/her. E.g. *player sends 1 12 23 34 45 49 or QP6 to 22591.*

- 8.2. Player then gets a response in which states the (6) numbers chosen, the date and time of play as well as a Wager ID/ on POS a receipt is printed which carries the same information. (Wager ID is a unique identification number used for the verification of winnings.) E.g. ***Your Game Play 1 12 23 34 45 49 staked @ N50 for Monday 18th January, 2016 was successfully entered on 18/01/2016 at 9:30am. Wager ID 12345678910***
- 8.3. The cost of each SMS sent to the Short Code **22591** is charged @ **NGN50.00** including Tax, except when **(INFO)** is sent to the Short Code. All the SMS messages sent to the participants from the server are free of charge for the participants.
- 8.4. All SMS entries closes at a particular time, i.e.: 7:45pm every Saturdays and the Draw is done at 8:00pm prompt.
- 8.5. Six (6) numbers are drawn from the 49 numbers and the 6 numbers are referred to as the winning numbers.
- 8.6. For all players whose 6, 5, 4, 3 numbers match out of the six (6) numbers drawn, they become winners and a winner notification message is sent via SMS to all. This is sent after the draw has been done. The winning numbers are published on the company website and a few national dailies.
- 8.7. To claim his/her winning in the lower tier division (N24,000 and below), winnings will be paid via Union Bank Mobile Wallet or Zenith Bank Branches or Our Mobile Money Agents and designated ATMs
- 8.8. To claim your prize in the high tier division, contained in the initial winner's notification message, winners are informed to visit SETPlc's Head Office along with the winning mobile number used for playing or contact our Customer Care **09086314669, 09086314670, 09086314671 and 09086314672** to redeem your prize.
- 8.9. After the draw, winners will receive an SMS to notify them of their winnings. You are a Jackpot winner if your 6 lucky numbers staked match all of the 6 winning numbers drawn.

9. Cost

- 9.1. The cost of each SMS sent to the Short Code **22591** is charged at **NGN50.00** including Tax, except when **INFO** is sent to the same Short Code. All the MT messages sent to the participants from this short code are free of charge for the participants.

10. INFO

- 10.1. Typical INFO Content: ***How to Play: SMS 6 numbers from 1-49 e.g. 1 12 23 34 45 49 or QP6 to get the system generated numbers and send to 22591. You are a winner if 3 or more of your numbers match any of the 6 numbers drawn for the same day. You are a Jackpot winner if your 6 numbers played match all of the 6 winning numbers drawn. All SMS entries close at 7:45pm and the draw is done at 8:00pm daily. Each SMS entry costs N50. Present you wager ID when claiming your winnings.***

11. Place, date, time and order of the tier prizes

There are 4 prize divisions in the game

Division 1: predict correctly all 6 numbers drawn (the Jackpot prize)

Division 2: predict correctly 5 numbers out of the 6 numbers drawn

Division 3: predict correctly 4 numbers out of the 6 numbers drawn

Division 4: predict correctly 3 numbers out of the 6 numbers drawn

Also, the prizes are split into 2 tier categories, as shown in the table below;

Prize Class	Weekly
“High” tier Prizes	6 Correct Predictions
“Low” tier Prizes	3 - 5 Correct Predictions

- 11.1. The same subscriber’s number (MSISDN) can win as many “low tier prizes” as possible during every weekly draw.
- 11.2. The formation of participants’ record for the whole period of the Game will start as soon as they select their first 6 numbers and ends after the weekly draw is held on Saturday.
- 11.3. Draws will be concluded every Saturday at 8pm.
- 11.4. The winner is notified by the organizer via phone call or SMS to their subscriber number within 2 days. The winner then has 7 days to claim their prize.
- 11.5. Prizes are derived from the total ticket sales, whereby a percentage sharing is distributed across all categories.

12. Terms of the tier prizes:

- 12.1. All tier winnings will be awarded within [7 days] after each games draws is concluded. Please read the game rule for further information on the website <http://www.setplc.com>
- 12.2. The exact date and place of the provision of the tier prizes shall be published on the official website <http://www.setplc.com>, as well as communicated to the winner via SMS or by calling the Customer Care number(s): **(09086314669, 09086314670, 09086314671 and 09086314672)**
- 12.3. The winners will be contacted by the Organizer. The winners may be required to confirm in writing that they are the legal holder of the subscription and that they are entitled to the prize and shall complete all the necessary documents provided by the Organizer. All winners must provide identification documents (where applicable) in order to receive the prize.
- 12.4. By participating in the Game, the winners agree that any of their data, including names, surnames, photos and video images, can be used by SET Plc. for advertising purposes with no prior consent of the winner and free of charge.
- 12.5. The Organizer will not select any runner-up winners and if the notified winner refuses the prize or fails to appear (either at the ATM/Bank or SET office) to collect it within 7 calendar days of notification, then the prize remains the property of the Organizer of the Game.
- 12.6. Prizes are a determinant of sales revenue; where the more the SMS Entries, the higher the prize pool
- 12.7. Where there are multiple winners in each tier prize division, the prizes allocated to that division are shared equally amongst the winners.

- 12.8. All winnings above One Hundred Thousand Naira (=N=100,000) and Jackpot Winners **MUST** come to the head office to redeem their prize. Presentation procedure as follows;
- (a) All collections to take place between 10a.m. and 5p.m. weekdays @ Head office
 - (b) The phone number used to play must be cited before payment presentation is made
 - (c) The play showing prediction SMS and notification of winnings must be seen on phone before payment
 - (d) Winners claim form must be duly filled
 - (e) Picture of the winner and their cheque would be taken
 - (f) Photocopy of winners ID must be given to the deliverer
- 12.9. Where the high tier winnings are below =N=100,000 and the winners cannot come to the head office due to out of state location, health or any emergencies, it would be paid into the winners account, but certain conditions must be met;
- (a) The winner must phone-in the Call Center with the winning mobile number and explain their inability to come for the cheque presentation, where it would be deemed acceptable or not
 - (b) The winner would provide their full details, which includes their name, residential address, name of their bank and account number
 - (c) The winners name given and name on the account must tally
 - (d) The account would be funded within 5 working days
- 12.10. Decisions made by the Organizer will be final and no correspondence will be entered into. Tier prizes are not transferable.

13. Limitation of liability

- 13.1. The Organizer accepts no responsibility whatsoever for, including without limitation, any error, omission, interruption, defect, delay in operation or transmission, communications line failure when it is not under its direct control and execution.
- 13.2. The Organizers reserve the right to temporarily suspend the Game for operational reasons (e.g. for repairs, planned maintenance or upgrades), whenever it is deemed necessary. The Organizers promise to restore the Game as soon as possible after any temporary suspension period.
- 13.3. While the Organizer will send the low tier prizes (3 – 5 correct predictions) to the winner via our partner bank ATM or an alternative means most suitable, the high tier winners (6 correct predictions) will come to SET office for their cheque presentation.
- 13.4. The Organizer advises participants to use caution and common sense when participating in the Game at all times.

14. Disclaimer of warranties

- 14.1. Participants understand and agree that they participate in this Game at their own risk and willingness and have not been coerced in any manner to enter the Game.
- 14.2. The Organizer makes no warranty, implied or express, that any part of the Game will be uninterrupted and error-free.

- 14.3. Neither the Organizer nor any of its directors, employees, agents or suppliers shall accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant participating in the game or as a result of accepting the prize.
- 14.4. The Organizer is not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer equipment, software failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination thereof, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation or downloading any materials in the Game.
